

VA and military hospital patient room doors

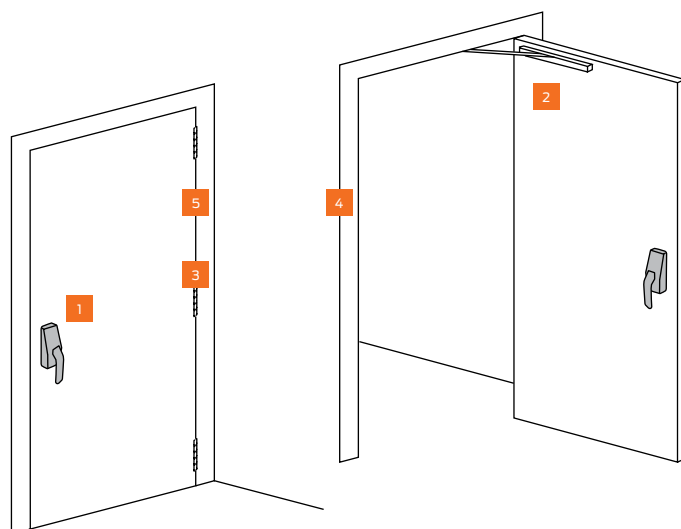
Government solutions

A hospital patient's room needs to be easily accessible so medical staff can push wheelchairs, gurneys or other necessary equipment through the opening, quickly and safely.

Traditional knobs and levers can prohibit safe and easy access by making it hard to open the door. Another concern is protecting the patient against the spread of bacteria and germs that can cause infections. These germs lurk on hospital surfaces that are touched by many people every day, including doors.

VA and military hospital patient room door operational requirements:

- Doors are usually unlocked during the day
- There should be free egress at all times

Building and safety codes may vary, but most hospital patient room doors include these standard features:
